Welcome, Warrant, and Invocation: Brenda Ridgeway, Warden, welcomed everyone.

Registrars: Cris Harter, Elizabeth Merritt, Kathy Goddard, Hanna Schneider, with Nancy Boccia for Zoom attendees. The Rev. Patrick Ward gave the Invocation. Priscilla Isner read the Warrant and called for the Quorum: Ann Pike-Paris reported 106 being in-person and on Zoom.

Quorum and Appointment of Tellers: Brenda Ridgeway called the meeting to order and declared the Annual Meeting in Session and appointed Tellers: Ike Cole, John Harter, Page McMahan, Jen Marlin. The Clerk appointed for the meeting was Priscilla Isner.

Minutes of the 2023 Annual Meeting: Priscilla Isner called for a motion to receive and approve the Minutes of the Annual Meeting held February 12, 2023, proposed by Page McMahan, seconded by John Harter, all approved.

Opportunity for comments:

Bill Mason asked about no money being set aside for the Discretionary Fund. Patrick said he is using money from 13 funerals this past year.

There was concern that Patrick was given only \$1000 for continuing education. Chris, the treasure, stated there is more money available if necessary.

Fund raiser amount seemed low. Chris explained that is an unknown number till the event happens. To balance the budget best the number be kept low.

TREASURER'S REPORT FOR CHURCH YEAR 2024

Operating Account

We have an excess of Income over Expenses of \$28.0K for the Total Year 2024 which will replenish our savings as part of our unrestricted reserves available for use in our future together.

<u>Income</u>: Pledge Income came in at 100% of budget (\$314K). Parish Giving beyond pledge income excelled, producing \$77.5K in income; +\$20K - 36% over budget. Budgets for Unpledged Income and Loose Plate were lowered slightly compared to last year in consideration of a large number of new pledges, but that was an error – the money kept coming as more new people found CHS.

The star of Other Income is Fund Raising Events. 2024 has income from 4 events, rather than just 3, but that far from explains the amazing increases in income compared to both last year and expectations. Fund Raising Events was \$30K over budget (222% over budget). The Solar Array income is under budget (by \$3K) due solely to the slowness of income generators to pay us.

To balance our 2024 Budget expenses, we drew 5.9% of our savings supporting operations (a portion of our funds invested at the DIT), which is LESS than we withdrew in 2023 (6.3%).

Total Operating Income of \$721.5K finishes the year at 106% of Budget.

Expenses: Total Expense of \$687.0K came in at 102% of budget. There were no unexpected expenses to note, but we continue to incur high expenses for the repair, maintenance and replacement of various parts of our substantial and aging campus.

Last year CHS adjusted staff and independent contractor compensation upward to more properly reflect current living wages for each position. Having had a good year financially is much the result of our caring staff and, so, year-end bonuses were paid, with gratitude.

Non-Operating Accounts

The Church of the Holy Spirit maintains 28 non-operating funds. These may be:

- Restricted (given by donors to the church for specific, temporarily or permanently restricted purposes), a category which includes our endowment funds.
- Designated (set aside by the Vestry for specific goals).

They may be held or spent over several years, unlike the operating account which is focused on annual spending for salaries, benefits, and immediate operating needs. These funds are held in checking accounts, a money market account, and in large part at our Diocese's Diocesan Investment Trust (see below)

Checking and Money Market Accounts

The church holds funds in checking accounts and a money market account, all at the Cape Cod Five Cents Savings Bank, which include the operating balance as well as the cash portion of the non-operational funds mentioned above. At the end of 2024 the total balance in these accounts was \$150,602.

Diocesan Investment Trust

Our invested funds are managed by the **Trustees of Donations to the Protestant Episcopal Church**, generally known as the Diocesan Investment Trust (DIT). Thirteen of our non-operating funds hold positions in this investment portfolio, which are outlined in the attached DIT report. These positions are invested in two funds at the DIT, with goals of 75% in the Stock Fund and 25% in the Income Fund.

Our investments in the Diocesan Investment Trust (DIT) finished strong, with a gain of 5 percent for the year AFTER our draw of 5.9% to support Operations for 2024. Even when our substantial withdrawals are factored in, our portfolio supporting operations (\$4,647200 at 12/31/24) still grew by over \$250,000.

2024 Outreach

The 2024 Outreach report is also attached for your reference (see p. 45). It lists Outreach donations from our operating budget, non-operating funds, and from our other organizations and committees.

Florence Kimball Society and Fund established

In gratitude for all those who remember The Church of the Holy Spirit financially beyond their annual pledges, we established The Florence Kimball Society and Fund. Future gifts from parishioners' planned giving and other gifts will be added to the already great generosity shared from previous givers. Funds will be managed by the **Trustees of Donations to the Protestant Episcopal Church** (DIT).

Conclusion

This great financial performance is driven by long time congregants pledging anew and new people who come through our doors and stay because they are well greeted. Our Bazaar, Rummage Sale and Antiques sales grew in excellence as well as income, and provide important open-door experiences attracting new members and great community building events for members. The principal explanation, however, is that Patrick agreed to forestall hiring an assisting priest. We plan to hire in 2025 and a transition plan to be able to afford this hire is in place (IRS/ERC funds invested but held aside for assisting priest hire.)

2025 Pledges in hand total 151 – we exceeded our Goal – Totaling over \$378K, with 71 Increased Pledges and 28 New Pledges.

We are blessed as well as being financially responsible stewards.

OPERATING BUDGET FOR 2025

The 2025 Operating Budget was approved by Vestry at its January meeting, and is presented, together with 2024 Actual and Budget figures below.

Overview: The big change is that we are planning to hire an assistant to Patrick during 2025. While a variety of uncertainties surround the plan, we have budgeted for a 75%-time Associate Priest for 6 months – reality may prove to be different, but we are providing a \$50K salary (\$70K total cost with pension & benefits) in our budget. We also have funds received from the IRS for the retention of employees during COVID set aside to help us transition into this additional ongoing annual cost. Recognizing that we are stretching this year to afford this additional hire, we have budgeted a total year deficit of \$5,500 to inspire us to identify additional income.

Income: Total Operating Income is budgeted at \$783K – 15% over our 2024 budget and 8.5% over 2024 Actual receipts. We met our **Pledge Participation Goal of 150 Pledgers** who pledged over \$375K, a 14% increase over 2024. 71 pledgers increased their pledges, and we have 28 new pledgers. WOW! Our Annual Fall Pledge campaigns since Patrick's arrival (2 years) have reflected the energy and commitment palpable in our parish and for which we all feel grateful and celebrated.

The DIT draw from our invested savings will increase from 5.9% budgeted in 2024 to 6% in 2025, but yield \$7K less in income due to a lowered value to our 3-year running investment value average.

To afford hiring an assisting priest, we still need additional income which we can access from monies received, and set aside, from the IRS for retaining employees during COVID. We have received \$63K to date and anticipate receiving a total of \$90K of which we have budgeted the use of \$30K in 2025 to allow us to hire this year.

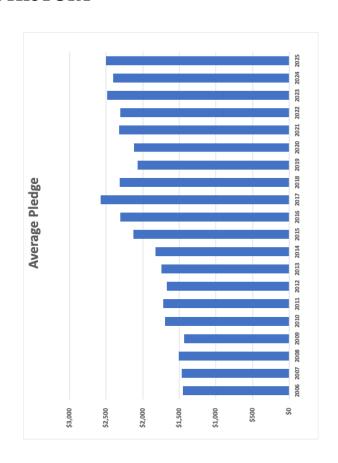
Expenses: We have budgeted a stipend of \$50K, with total cost including benefits of \$70K, to hire an assistant to Patrick – this is calculated as hiring as Associate priest for 75%-time for 6 months. Other expenses are similar to 2024 – without the additional priest expense, all other expenses are budgeted to increase only 3.5%.

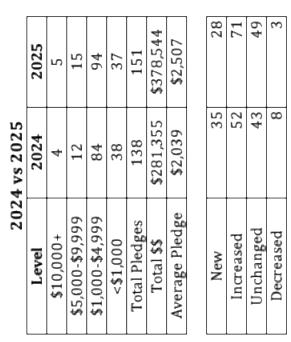

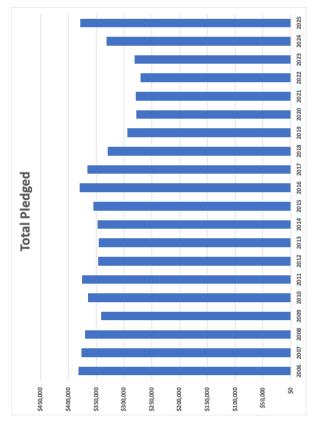

The Endowment, General, Nickerson and Chapman (75%) funds support the operating account.

The Chapman Bequest also supports the Capital Improvements fund (25%).

The Galley West fund belongs to the Galley West Artists' Gallery. We administer it for them.

The Hagenbuckle fund provides camp scholarships for special needs children.

The Memorial fund is used as the Vestry may direct.

The St. Fiacre fund supports the gardens and trees within the gardens.

The Capital Improvement fund supports repairs and additions to the property which would be eligible for depreciation in a commercial setting.

The Scholarship fund provides \$1,000 scholarships to deserving graduates of Nauset Regional High School.

The Seale Varga fund supports the parish's communications and media activities.

The Badger/Morgan/Heed Fund supports Outreach.

REPORT FROM THE RECTOR

2024 was my second full year as your rector. As I review just now the whole of my two years serving alongside you, I understand each 12-month span as keyed to a particular question:

- 2023: "Who are these folks?"
- 2024: "What on earth are we doing here together?"

While I'll continue to ask these questions for as long as Roger and I are living here with you, 2024 asked many of us to do some particular thinking about our identity and mission in our very particular time and place. One of the first actions your officers and vestry undertook with me after last year's annual meeting was revising our mission statement. The result:

Terse and "verby" (according to an editor friend of mine) our revised statement looks both "up" to a three-personed God and "out" towards other people –old church friends as well as newcomers; folks living nearby who don't yet or may never have a church; customers of our Free Shop; children and teens having lunch and snacks daily through our summer Food 4 Kids Ministry, exhibiting artists and visitors at Galley West; clients of the 18 service organizations on and off-Cape to which we offer cash grants each year. All of these are our neighbors – and in a culture of rampant narcissism we are called to be an outward-looking community, nourished by both Word and sacrament to witness against the forces that threaten human life and flourishing. This is what, on earth, we are doing here together.

I'm partial to these particular words of Episcopal priest and author Dwight J. Zscheile from his book *People of the Way: Renewing Episcopal Identity.* Zscheile understands church as

...a space of meaning-making and learning through communal conversation, not simply a refuge for private spiritual yearnings...decisions that shape the personal and communal life and witness of the community are informed by deeper engagement with one another and the riches of our theological heritage. ¹

I shared this understanding of church last January at the start of our 7-week "Faith Fundamentals" soup supper program. Eight adult discerners in that program ultimately decided to be received into the **Episcopal Church** on April 13, on the same day that seven of our teens were confirmed here by Bishop Alan Gates in his last visit to us before retiring.

What Zscheile refers to as "learning through communal conversation" is very much a part of the CHS experience. Small group scripture encounter is available here *twice a week every week*: on Sunday mornings in our Fireplace Room before church ("**Glimpse of the Gospel**") and on Tuesday mornings via a Zoom-based *Lectio Divina* session. We also began this year to offer **Sacred Ground**, our church's 11-session dialog series on race in America. 19 parishioners completed this program between July and December.

We have learned a lot this year about what works here to foster "deeper engagement" too! We trialed and suspended a "Tuesdays at Two" afternoon board game and tea session that never took off. Our "Neighborhood Tables" fellowship program -- 8 groups meeting across Orleans, Brewster and Eastham with a focus on eating together, conversation and prayer - launched late in 2024 and is off to a strong start with approximately 80 participants. All of these initiatives support the focused *Invite/Welcome/Connect* work we did together as parish in 2023. "How do we create more

opportunities to hear from each other about our own development as Christians?" asked one thoughtful parishioner recently. This remains our continuing work.

You'll learn more about our shared ministries in all of the pages that follow here. Before closing, though, I'd like to highlight a few other events from this past year that signal renewing energy:

James Carroll's Palm Sunday Talk: Carroll, a part-time Cape resident and the author of many books including *Constantine's Sword: the Church and the Jews*, visited with us to present "Lethal Texts in Holy Week: An Unfinished Reckoning with Antisemitism." At a moment when our nation was particularly riven by ongoing war in Gaza and Israel, Carroll was able both to reflect and to honor hotly diverging perspectives before an audience of 200 – parishioners and many visitors.

Special Liturgies: We created and offered several special evening liturgies for the broader Orleans community this year, including February 2 (Choral Evensong for Feast of the Presentation), November 4 (Election Eve Prayers for Our Nation), December 6 (The Colombian Día de Las Velitas or "Feast of the Little Candles") and December 18 (Advent Lessons and Carols). In a show of thanks and companionship following December 6, our Colombian neighbors hosted uproarious and joyful holiday games at Coffee Hour on December 22. We hope these Advent traditions continue!

Sustainability: We are blessed in our parish by the continuing work of more than a dozen disciples who understand church finance and sustainability as sacred ministry. Since 2022 we have managed to decrease our endowment draw significantly, boost lay employee salaries, increase participation in our annual stewardship appeals by approximately 40 households, and this year launch an organized planned giving program, the Florence Kimball Society. We have much more planned for this new year.

With their own budgets, websites and volunteer rosters that transcend our parish directory, both **Food 4 Kids** (our 9-week summer feeding and literacy program) and **Galley West** (our community art gallery) sometimes look and feel like independent organizations. They are very much ministries of our parish, and each saw significant growth this year. F4K hired **Jenn Gale** as Executive Director and Galley West had its best sales year yet!

Creation Care: While we are a parish of many political perspectives, I have discerned a marked unity on the topic of climate change and creation care. We observed our first series of Creation Care season liturgies in 2024, three Sundays culminating in the October Feast of St. Francis. Dr. Stephen Young of Salem State University's Geography & Sustainability Department visited with us on the first of these Sundays to talk about his climate research as well as his faith. CHS was recognized as one of one of our Diocesan pilot parishes for the Episcopal Path to Creation Justice Program, largely on the basis of our innovative agroecological terracing and runoff mitigation work. Thanks to the ongoing work and investment of our parish, our four acres are themselves becoming a working "filter" protecting our local sole-source aquifer.

We have come a long way and grown substantially this year! In this coming year we look to:

- Identify and welcome a second priest or lay pastoral assistant
- Complete a just-started revision of our web site
- Continue an in-process evaluation of capital expenses and funding possibilities
- Continue to create opportunities for community building, education and connection with an eye towards the specific spiritual needs of seniors
- Evaluate space use here on campus and determine if room use is meeting current pastoral and program needs

In the pages that follow here you will read more about highlights and milestones of this past year. About continuing ministries such as Buildings and Grounds, Pastoral Care, Outreach, and Church School. More than forty parishioners have contributed to this annual report. Please read on to meet them!

I do here wish to thank Anne Koehler, Celia Calhoun and Priscilla Isner for the hours of organizing and editing which have resulted in the report you are reading now. I also want to thank my colleagues on staff: Director of Music Joan Kirchner, Debbi Manning (who has resisted any title I have suggested to her but who ensures that our office runs smoothly and that leaflets appear every Sunday), Facilities Director Wayne Currey and part-time sextons Matthew Harman and Faith Stineford, who with warmth and generosity make sure that event setup and breakdown and cleaning and so many other forms of help and assistance are here when we need them.

Please keep each of them, as well as our entire church family, in your prayers.

REPORT FROM THE MINISTER OF MUSIC

The adult choir continues to provide music leadership for every single Sunday in the church year as well as special services such as those throughout Holy Week. Biographies for Individuals Placed in Nomination

Warden

Priscilla Isner is nominated to serve a two-year term as Warden. Priscilla is currently serving a one-year term of an unexpired two-year term as Warden and has also served as Clerk of the Vestry in addition to two years as a Vestry member. Priscilla has been an Episcopalian her entire life, which began when she was baptized and confirmed at St. John's, Staten Island, NY. Clerk

Treasurer

ADMINISTRATION

Affinity Group Vestry Liaison – Sarah Gregory

AV Technical Team

<u>Mission</u>: The AV Team is primarily responsible for providing our CHS worship services to our YouTube audience. This audience consists of parishioners who are unable to be present at the service and members of our parish who reside at The Terraces in Orleans, as well as anyone from the public wishing to view a service at their convenience.

Major Accomplishments/Activities in 2024

- A new and improved microphone was added for use in the church. We have met with Kevin Shanley of East West Associates to research possible improvements to our sound system in the church.
- We have added a lavalier to the microphone equipment in the Parish Hall.

Responsibilities/Challenges

- The team sets up the microphones at each service and monitors the sound levels in the sanctuary
 and the sound levels on YouTube. They also provide support for functions using the sound
 system in the Parish Hall.
- In the sanctuary, there are two cameras one over the central aisle in the north transept leading to the altar and the second over the altar near the organ. A third free-standing camera is available to be used in the church or in the parish hall for special events (i.e. the annual meeting and the MLK breakfast).
- The team also provides support for groups using Zoom in the Fireplace Room. The church computer connects to the sound and video equipment easily for those meetings which include members via Zoom. Debbi Manning is responsible for the church's Zoom schedule.
- Finally, a member of the AV Team travels to The Terraces each Sunday with a computer, bulletins, and communion to facilitate worship there on the large screen tv in the Library.
- Our greatest challenge is to attract more members to our team. Many of our members have multiple duties on a given Sunday. Another challenge lies in the management of our YouTube account to increase our presence there. Our present AV staff has no expertise in this area.

Database and Online Giving

<u>Mission:</u> Our mission is to create, maintain, and optimize a secure database to facilitate many aspects of our life together, including communication, financial stewardship, pastoral care, and the acknowledgement of key dates in our lives. The online giving platform works in tandem with the database.

Major Accomplishments/Activities in 2024

- Church membership: Continually updated the database; identified potential new members from non-member giving trends, added new fields (e.g. "CHS in will")
- Communication: Published periodic updates of our Parish Directory; facilitated snail-mail and other communication to targeted groups; tested option to use the database to schedule and remind volunteers (in this case, Counters)
- Financial Stewardship: Issued Giving Statements quarterly, most via email. Thirty-three people used online giving to contribute \$48,420.56 toward pledges and general offering as well as special donations, including \$7,300 for Food 4 Kids. Assisted the Stewardship Team with targeted pledge mailings, tracking pledging, and setting up pledge envelopes. Helped revive the weekly Counter Teams.
- Pastoral Care: Continued adding emergency contact information to assist the Rector and Pastoral Care Team

Responsibilities/Challenges

- Ensuring information for each member is complete, accurate, and up to date, which relies on others to provide it. The new "yellow sheet" for new member information has helped.
- Encouraging/teaching more people to use recurring online giving and looking into adding the option to pledge online for the 2026 campaign.
- Succession planning: Identifying others with database and data analytics experience

Sustainability & Stewardship

<u>Mission</u>: Our mission is to help ensure the long-term financial sustainability of our parish by assisting and advising Vestry with annual pledge campaigns, planned giving programs, capital campaigns and other sources of revenue. In doing so, we seek to foster a culture of giving which will sustain our church's operations and physical plant, empower our ministries, and fulfill our commitment to serve and support our congregation and our broader community for generations to come.

Major Accomplishments/Activities in 2024

- Achieved last year's goal with the launch of a planned giving program to promote donations to the parish via estate/will gifts. The program includes establishment of the Florence Kimball Society for the purpose of honoring individuals who have remembered CHS in their estate/will plans.
- Achieved last year's goal of sponsoring a successful pledge campaign, including parishioner testimonials, small group home gatherings, tailored mailings, and strong rector support.
- Recorded 151 pledges of financial support for our 2025 calendar year, including 28 new pledges. Raised \$378,544 in total dollars pledged, an increase over the prior year of 14%.
- Successfully developed and launched the Neighborhood Tables initiative to bring together small groups of parishioners for worship and community.
- Progressed with development of ideas for action in the future.
- Continued to cultivate a committee of diverse talents to assist with achieving the Parish's goal of a year-round focus on financial sustainability and stewardship.

Responsibilities/Challenges

- Create a framework for ongoing support of our planned giving program and the Florence Kimball Society.

Buildings and Grounds

<u>Mission</u>: We are a team dedicated to maintaining the buildings and grounds that God has lent to us at CHS. We volunteer our time and talent to love CHS as effective environmental stewards.

Major Accomplishments/Activities in 2024

- Solar field terraces and hillsides weeded and maintained; new projects underway to cope with water runoff at the main driveway entrance, Kimball House, and the old front entrance.
- Continued grooming of grounds with removal of old plant materials
- Tree labeling project completed with signs created by Kimball Guild
- Garden parties continued with over 400 volunteer hours across 15 workdays
- Memorial Garden revival underway
- Campus gutter systems repaired and cleaned
- Campus-wide roofs showing moss and lichens cleaned and treated
- Admin building HVAC issues resolved
- Campus wide door and windows inspected, inventory developed, and repairs scheduled, as needed
- Parish Hall condenser field and air handlers replaced, as units were failing
- Parking lot resurfacing project completed
- Memorial Bell Tower repaired and renovated
- Children play area railings repaired
- Entrance to campus erosion control development installed

Responsibilities

Grounds

- Anticipating and identifying needed replacement elements of complex systems over the next 2-5 years
- Securing adequate Cap X funding to accomplish what is needed

Mission

Together is the monthly newsletter of The Church of the Holy Spirit delivered via Constant Contact which provides news and pictures of our common life. The newsletter goes beyond the announcements in the weekly bulletin and those made during worship services.

Major Accomplishments/Activities in 2024

- Together editor Susan Sasso stepped down after many years of service. Sue had expertly
 shepherded our newsletter from its hard copy format through weekly email editions (Being Together
 Apart) during Covid to its present form. We extend our warmest thanks to Sue for sharing her
 creativity and organizational talents with us and her willingness to tackle significant projects for
 so many years!
- Eleven monthly newsletters were delivered on time this year. We skipped the month of September in 2024 due to the transition between editors. Each edition included timely articles and events with photos for many of the articles.
- The newsletter is delivered via email to about 340 individual email addresses with an average 66% open rate, which is at least 20% better than the industry average. We also send hard copies to members who do not have email access.
- Brenda Ridgeway has assumed the responsibility for editing the newsletter each month.

Responsibilities/Challenges

- Keeping the editions informative without making them so long people do not want to read them.
- Discover ways to engage the more than 100 people in our contact list who do not open our newsletter each month.

Ministry Team

- Every parish ministry contributes articles, and other members supplement the text with wonderful photos. With the help of the Rector and Wardens reviewing and proofreading each issue, we keep everyone informed.

Website & Social Media

<u>Mission</u>

- Standardize internal and external information for placement on social media and the website.
- Develop and ensure consistency in branding across internal and external communications including print advertising.

Major Accomplishments/Activities in 2024

- Increase in traffic on Facebook those liking the page at 704; with number of followers at 779; in 2024 the page had 32,000 views.
- Reels on Facebook (and Instagram) increased our visibility and provided a creative and fun way for people to see us.
- Significant increase in numbers attending parish events (via Facebook posts and reels and Chronicle ads).

- Changes to website continued to be handled by office and volunteers resulting in more timely updates and cost savings overall (changes of a more complex nature continued to be handled by our webmaster, COLEwebdev).
- Use of the website as a resource for photos, to listen/watch sermons, links to YouTube channel, and the secure portal for pledges and donations.

- Continued increase in those who say the website and social media brought them through the doors for services.

EDUCATION

Adult Christian Formation

<u>Mission</u>: In addition to *Glimpse of the Gospel*, CHS offers regular opportunities to learn more about our faith and its history, scripture and their interplay with the wider secular cultures in which we live. Both learning series and Sunday forums (with or without guest speakers) are organized by the rector with frequent participation by parishioners on panels or in small group breakout discussions.

Major Accomplishments/Activities in 2024

- 7-session "Faith Fundamentals" series (January-March) surveying theology, doctrine and history in lecture and small-group format. Attended by 45 parishioners.
- 11-session Sacred Ground dialog circle series (July-December) completed by 19 parishioners. Using a syllabus and materials assembled by the national Episcopal Church and supported by a visiting deacon, Rev. Marilyn McMillan, Sacred Ground explores race and identity in America while linking its history to our faith and family histories.
- Palm Sunday Lecture: "Lethal Texts in Holy Week: An Unfinished Reckoning with Antisemitism" by author James Carroll.
- Other guest speakers in 2024 included Dr. Stephen Young, professor of ecology and sustainability at Salem State University, Molly Purdue of Alzheimer's Family Support Center of Cape Cod, Hadley Luddy of Homeless Prevention Council and Jeni Wheeler of Family Table Collaborative.
- Parishioners also participated in panel discussions on racism (Sacred Ground) and climate change (Katharine Hayhoe's *Saving Us*) and in our annual Easter season "poetry slam."

<u>Challenges</u>

- Identifying, recruiting and supporting facilitators for small group discussions
- Capacity of rector to create and lead programming and recruit guest speakers without additional staff and volunteer assistance.
- Additional bandwidth needed to create materials and outreach in support of marketing learning opportunities to wider community.

Church School & Youth Group

<u>Mission</u>: To welcome, support and engage youth and families in learning about the word of God. Within this teaching is embedded love, respect, and acceptance of all people.

The Youth Group Mission is also to continue our fellowship inside and outside the church walls with community service and exploration.

Major Accomplishments/Activities in 2024

- We had several successful events that combined current youth and families with not only
 parishioners but also community youth that had not attended Church functions before. These
 were Youth Group and Church School sponsored events. Some of them were: Pumpkin
 Carving, Gingerbread House Decorating, and Advent Wreath Making.
- We had a new shared event that Monica Montoya and her family led. We learned about Dia de las Velitas (Day of the Little Candles) and shared in this Columbian tradition. We all contributed food and ate together after the children lit our candles and we offered up a wish for the world in the new year to come.
- The middle and high school class finally completed the Peace Sign Nature Collage that we had been working on for two years.
- We continued to meet downstairs 3 Sundays a month with many of us coming up to the church for communion. The Fourth Sunday of the month worked well as our Youth Sunday when we all participate in the service as we are able.
- We spent a wonderful time at the Barbara Harris Camp aiding in their spring and fall clean up. These events were attended by almost all the Church School families.
- We were pleased to host Confirmation for many students and adults of the Cape & Islands Deanery at our church. Seven students participated in our confirmation class. Six youth from our church were confirmed.
- We have welcomed two new students into our Godly Play program
- Both the Christmas Pageant and the Epiphany Pageant were attended by students and adults near and far, including alumni as well as family members.

Responsibilities/Challenges

Responsibilities:

- Sharing Godly Play stories with the children 5 years of age up to 11 years of age. Godly Play is storytelling combined with thoughtful questions and dialogue about the story and how it might relate to where the children are and what they have experienced in their lives up until now, as well as how they might explore and change what they do or how they think based on these teachings. The stories are followed with free play, creation (artistry), and a shared snack.
- The Middle/High School group curriculum is similar to Godly Play only we learn how to use (look up) readings in the Bible and then have discussions around a reading for that particular Sunday. This class is taught using the Sunday Paper as well as articles from Faith Lens. There is much discussion and wondering! This class also has a creation section following or during the discussion. We are always thinking about ways in which we are growing and changing and how Jesus/God's modeling or message can guide us or give us examples to live and learn.

Challenges:

- How to continue our small classes while drawing new youth and families into our church and church school/youth group!
- Creating church school and youth events that appeal to varied ages since we are such a small group.

- The Florence Kimball Society was introduced to the parishioners at The Church of the Holy Spirit with a coffee hour presentation led by Patrick. Photos of past parishioners who have generously remembered the church were shared in a well-received PowerPoint.
- Brochures have been printed and distributed to interested members.

Responsibilities/Challenges

- Planned giving, alongside annual stewardship and capital fund drives, is vital to Christian stewardship and helps fund CHS's future ministries.
- Our challenge is to attract more parishioners to consider the church when preparing their wills and final plans. By sharing our resources after death, we continue our personal support for cherished organizations. CHS thrives today in no small part because of the generosity of those before us, and a planned gift of any amount extends that love to future generations.

Fresh Holiday Arrangements Sale

<u>Mission</u>: To extend financial aid to organizations in need on Cape Cod by engaging volunteers from The Church of the Holy Spirit and from our community to make and sell fresh holiday greens arrangements.

Major Accomplishments/Activities in 2024

- Tried shifting the sale to the second week in December thinking it would extend the life of the arrangements through to New Year's Eve. The sale was challenged by heavy rain the first day and limited parking due to a funeral the second day.
- Successfully recruited volunteers from other churches because the money was going to local charities.
- Continued with advertising via signs at the corner and in front of the church and posters around town; ad in The Chronicle; postings on CHS's website and Facebook; announcements during church service; and presentations during coffee hour.
- Increased our fundraising (\$3,665 gross)

Responsibilities/Challenges

- Encourage more participation and support from our CHS and local communities
- Improve training methods for new volunteers
- Will return to scheduling the Holiday Arrangements Sale for the week after Thanksgiving as it is easier for all concerned.

Holiday Bazaar

Mission: Each year a team of volunteers works together to produce the event on the first Saturday of November. The bazaar is a major fundraising activity with a percentage of funds designated for outreach programs. The focus is to produce an event that highlights The Church of the Holy Spirit and welcomes guests from all over Cape Cod to shop with unique internal and external vendors, enjoy lunch in the CHS Café, and experience the church through tours and hospitality-focused activities.

Major Accomplishments/Activities in 2024

- Exceeded fiscal expectations by 30% (\$17,000 gross).
- We opened the entire lower level, increasing the number of artists/tables. Décor and a hospitality table with cider and cookies enhanced the guest and artist experience. There was a marked increase in visitors and shoppers from opening at 9:00 to closing at 2:00 p.m.
- 25 artists and artisans participated.
- Continued with additional activities highlighting The Church of the Holy Spirit (hammering demonstration, scavenger hunt, self-guided tour of the art). These activities were well attended and 6 people joined the service the following Sunday because of the tour.
- Increased the number of themed baskets.
- Better jewelry moved to the Fireplace Room, and we had record sales.
- Added additional holiday decorations including a large tree on the stage. The Parish Hall was full
 of the holiday spirit.
- Engaged over 40 volunteers including many newcomers to the church.
- Continued to increase Facebook and other marketing tools, including reels.
- Benefited from over 2,600 cookies and other food items donated to the food table which sold out.

Challenges

- While the jewelry tables were highly successful and secure in the Fireplace Room, we need a better system for managing traffic and payment. We will work on that for 2025.
- Kimball Guild needs a better location, and we hope to highlight them more in 2025.
- Managing increased traffic and parking congestion on campus. We did not hire a police officer detail this year and will be sure to do so in the future.
- Improving website information and traffic. This continues to be a challenge, and we hope to have new website changes to increase information and post an accurate calendar of times.
- Clean-up crew needs to be increased and scheduled.
- Maintaining and increasing team leadership.
- Engage more children/young adults in the planning and day of activities.

Rummage Sale

<u>Mission</u>: To create a fun outreach event that unites parishioners and develops and strengthens friendships beyond The Church of the Holy Spirit community. It's our intention to represent The Church of the Holy Spirit positively and donate a portion of the proceeds to a specified charitable organization.

Major Accomplishments/Activities in 2024

- This year the Planning Committee decided to add antiques and some better-quality items in hopes it might bring in additional revenue as well as buyers. We designated the Fireplace Room for these items and named it the Estate Sale Room. This gave us an opportunity to expand our market base beyond rummage sale shoppers and to also target estate sale shoppers.
- Marketing was key this year, focusing on new ways to bring in additional donations and to attract new shoppers. Social media and online advertising were used to broadcast the event Cape-wide.
- More than 30 volunteers showed up the week of the sale to unload cars, unpack boxes, and to sort, price and display the items on tables, floors and walls. Just as many volunteers worked during the sale assisting in the parking lot, greeting shoppers, working on the floor, as item tabulators and cashiers, and helping with breakdown and clean-up.

- Operated Friday, May 2, 4:00 pm-7:00 pm and Saturday May 3, 9:00 am-12:00 noon
- The number of donated items we received exceeded our expectations
- New display signage was designed
- The social media marketing campaign was beneficial, and we learned a lot
- Tom and Sally Dewing graciously cooked/served us lunch on May 2nd (with their volunteers)
- We had over 100 shoppers waiting in line when the doors opened on Friday at 4:00pm
- The Estate Sale Room was both popular and lucrative
- New display signage was designed
- We surpassed our financial expectations (\$13,000 gross)
- We donated a portion of proceeds from this year's sale to the Family Table Collaborative
- At least 3 of the volunteers have become parishioners
- Most of the volunteers have already expressed interested in the 2025 sale

Responsibilities/Challenges

The CHS Rummage Sale offers a wide array of gently used goods at affordable prices, which is why the event boasts a long, successful history.

Major Accomplishments/Activities in 2024

- Chamber of Commerce reception
- Church School "welcome back" Cookout!
- "Feast of Little Candles" evening program reception

- We have also added and welcomed the extra help of a decorating leader and team led by Meredith Perkins.

Diocese of Massachusetts 239th Annual Convention

"One Body in Christ, Members One of Another: Reconciliation and Belonging in an Age of Division" Saturday, November 9, 2024

Mission: The Diocese of Massachusetts Convention is an annual event convened to conduct the business of the diocese, including elections to relevant positions, the annual budget, and approved resolutions. Attending members are all licensed diocesan clergy and two delegates from each of the 180 parishes (totaling some 600 people).

Major Achievements/Activities in 2024

- Keynote Address (https://www.diomass.org/news/diocesan-news/video-address-bishop-whitworth-2024-diocesan-convention) given by Bishop Julia E. Whitworth, describing her observations on a time of transition for our diocese. She discussed three narratives: 1) "The Diocese of Massachusetts is a Complex System", 2) "We Are Really Congregationalists, You Know. It's a New England Thing." and 3) "Trauma, Truth-Telling and Solidarity". Bishop Whitworth concluded her remarks by expressing sincere gratitude to the leadership of the diocese, all those involved in bringing her to this place on her journey, the diocesan staff and Bishop Carol Gallagher, Assistant Bishop.
- Holy Eucharist service was celebrated.
- The diocesan budget was approved.
- Election for the various positions on committees were held (10 uncontested, 2 contested).

- Voting on resolutions (https://www.diomass.org/diocesan-convention-2024, scroll down for resolutions) covering:
 - Clergy compensation and benefits
 - A call for all leaders to complete the "Dismantling Racism Through Racial Healing" program over the coming year as a trial period (clergy, lay leaders and staff).

Nauset Interfaith Association

<u>Mission</u>: The Nauset Interfaith Association was established in 2009 as a 501c3 non-profit association of clergy and laity from over 20 faith communities on lower and outer Cape Cod. Our mission is to deepen our mutual understanding of our faiths; provide mutual support and understanding for each other; and work together for justice in our wider community, especially by standing with the poor, marginalized and oppressed.

Major accomplishments and activities in 2024

- Several events engaging with indigenous residents of Cape Cod regarding environmental practices and principles.
- Raising community awareness of gender identify issues among youth and mitigating increasing suicidal and marginalization thoughts.
- Engaging and supporting migrants who have moved to Cape Cod from the Caribbean, Africa, Central and South America, Ukraine and other places.
- Support for the Brazilian Resource Center in Hyannis.
- College scholarships and emotional support, as needed, for approximately 10 at-risk students.
- Continuing dialogue with police chiefs on the lower and outer cape towards developing cooperative community safety and interaction.
- Educating ourselves and our wider Cape community.

Responsibilities/Challenges

- Participation in our monthly meetings needs to be improved.
- Our online website needs more attention as does our publicity in general.
- We need deeper and broader financial support
- Engaging and communicating with our political representatives on the local, state and federal levels.

<u>Mission</u>: Food 4 Kids works to alleviate childhood hunger and promote literacy on the lower/outer Cape by bringing together The Church of the Holy Spirit and local communities to provide free meals and free books for children and teens in the summer when schools are out.

Expand our reach

Challenges from '23 included addressing our capacity to meet continuing increases in demand.

- Maintained 13 of 15 sites from 2023
- Added 2 Grab & Go sites and supported launch of 2 new Community Fridges
- Extended service by 1 week (9 to 10 weeks)
- Added 10 A-frame signs, and promotion materials in Spanish, Portuguese, Haitian/Creole
- Attend more public events

- 44,643 meals served to children, a 1% increase from 2023
- Served 1,101 meals at new site locations
- Served 1,154 meals across 5 sites in the additional week of service
- Increased awareness with bigger signage and multiple languages
- Increased the # of new volunteers (39)
- Engaged 135+ volunteers who gave 1,964 hours over 10 weeks, equivalent to 5 Full-time Staff

Improve nutritional quality and diversity of meals

- Prepared 4,200+ hot lunches over 10 weeks
- Added shelf-stable protein to AM snacks
- Replaced juice with real fruit for PM snack
- Increased satiety and satisfaction of the meals we served
- Increased the nutritional value of meals beyond USDA requirements
- Sourcing single-serve fruit & protein from new vendors resulted in more efficient food prep

Challenges

- To sustain and expand our mission long-term, a more formalized Board of Directors must be put in place to provide strategic oversight and expand fundraising capabilities. This is currently in process and the new Board plans to kick off in February.
- Explore revisions to our sites to maximize reach to hungry children, add convenience for families, minimize waste, and appeal to children of all ages with a focus on 15-18. This includes considering our Grab & Go sites which had a lot of meals leftover, especially early in the season; 40% in Orleans, and 57% in Brewster.
- Maintain nutritional quality and diversity of the meals we serve through fundraising. We received
 positive feedback on 2024 menu changes; however, food costs went up 33%. This is in part due
 to overall inflation, and the fact that the USDA reimburses based on a national average vs. 29%
 higher food costs on Cape Cod.
- Encourage sites to focus on congregate eating. Many sites end their programs at noon, and it can be a challenge to get children to eat as a group. We will seek to enhance our special programs during lunch to encourage congregate eating.
- Find efficiencies for serving hot meals: The materials needed, meal assembly process, packaging, and preparing for the delivery of hot meals changed each week, requiring agility on behalf of the operations and kitchen managers, intern, and volunteers. This learning will result in increased efficiency next season.

<u>Board of Directors</u>: F4K is in the process of establishing a more formalized Board of Directors with 50% representation from The Church of the Holy Spirit and the remaining coming from the community. Current confirmed members include: Brenda Ridgeway - Board Chair (11 years), Anne Koehler (9 years), Jeanne deCervens (new), Brian Schnetzer (new), Joy Jordan (new), Allison Wetzel (3 years), plus two open spots, as well as Jennifer Gale as F4K Executive Director (1 year) and Rev. Patrick Ward as Rector.

<u>Staff</u>: 4 people are core to our operations at the church: Operations Manager - Anne Marie Mullin (8 yrs), Kitchen Manager - Julie Thompson (3 yrs), Operations Assistants - Ray and Lizzie Thompson (2+ yrs). 8 people provided oversight of the locations we serve: 1 Site Manager - Jo Miller (1 yr) and 7 Site Liaisons - Jacqui Gale (1 yr), Chris Gray (2 yrs), Matt Montiero (4 yrs), Kisten Olsen (1 yr), Kathryn Rielly (1 yr), Becca Seavey (1 yr), Morgan Trimper (1 yr).
